

## The Bachelor Lawsuit Press Conference: Top Press Results

#### **Executive Summary**

Both ahead of and following Wednesday's press conference, our outreach efforts surrounding the Bachelor lawsuit garnered overwhelming media attention from national, entertainment and local press, including The Today Show, Associated Press, Reuters, USA Today, CNN, Entertainment Weekly, E! News, The Tennessean, and others.

Many outlets used Tuesday's media advisory to write stories and even produce video segments in advance of the press conference, relying on the event only to expand on their initial pieces. However, the advisory buzz lengthened the life of the story, and helped frame the lawsuit as a long-overdue pursuit of "equal opportunity"—a message further reinforced at the press conference itself. Aside from a few minor inaccuracies—such as initial speculation on Chris Johnson's identity, and just how many people were involved in the lawsuit—coverage was overwhelmingly fair and favorable. The Associated Press produced an especially thorough, favorable story that was picked up by hundreds of outlets. Overall, online searches indicate that at least 700 articles or blog posts were published on the issue since the advisory went out, and we continue to receive interview requests from outlets across the country.

The news has also already made a remarkable public impact. Several dozen videos of personal reactions to the story have been posted to YouTube, and one radio host has even launched a <u>"Change the</u> <u>Channel" campaign</u> against the Bachelor in support of the lawsuit.
